For application to ponds, lakes, fountain and ornamental bodies of water.

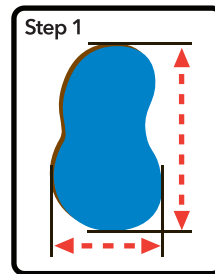

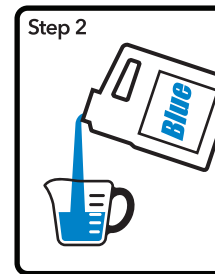

HOW TO USE

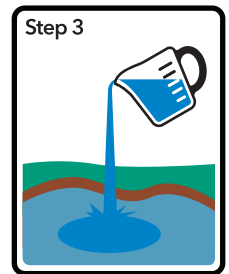
Pour the correct dosage of this product directly into the water from several different locations to improve dispersion. Adjust the quantity on follow up applications to achieve the desired appearance for your waterbody. Consider using waterproof gloves while handling this product to protect against staining hands.



Step 1
Determine the size of your pond.
1 acre = 43,560 ft. sq.



Step 2
Measure the desired amount of dye.
(See table below)



Step 3
Pour the product directly into the pond.
(See "How to Use")

HOW OFTEN TO USE

Apply this product starting early in the season or whenever you desire to alter the color of your pond. Repeat applications may be made when color is no longer at the desired intensity.

HOW MUCH TO USE

Apply this product at a rate of 32 fluid ounces (fl.oz.) per 1 acre foot of water. (One acre foot of water is 1 surface acre 1 foot deep). To determine your water volume in acre feet, multiply the surface area (acres) of the pond by the average depth (feet). Use the Application Rate Guide below for recommendations for common pond sizes and depths.
