EutroSORB<sup>®</sup> WC is a proprietary solution developed specifically for rapid and stable inactivation of phosphorus from the water column of a variety of water bodies such as lakes, reservoirs, ponds, rivers, streams, canals, ditches, etc. EutroSORB<sup>®</sup> WC is a high performance, water-soluble phosphate binder that does not stain equipment or features.

### DIRECTIONS FOR USE

**Obtain Required Permits:** Consult with appropriate state or local water authorities before applying this product in or around public waters.

### APPLICATION INFORMATION

This product can be directly applied to or injected in surface waters and can be used in or around public waters.

For best results, distribute EutroSORB WC uniformly over the surface of the waterbody or the area targeted for phosphorus inactivation. When making applications to flowing waters (e.g., rivers, streams, ditches, etc.), drip or inject EutroSORB WC at a location where adequate mixing occurs to optimize phosphorus binding.

The phosphorus binding of this product will depend on water quality parameters and site-specific conditions. Please consult a SePRO Technical Specialist for guidance in implementing a treatment program to achieve optimal results.

Apply 10 PDUs of EutroSORB WC to inactivate 1 lb. of phosphorus from the water column.
